Viking CCS Pipeline application accepted for examination

Welcome to the first community bulletin for the Viking CCS Pipeline project, a new carbon dioxide pipeline between Immingham and Theddlethorpe.

2023 has been a significant year for the project. Having finished our statutory consultation and a further targeted consultation, we submitted our application for development consent. We are delighted that our application has been accepted for examination by the Planning Inspectorate, which will now carefully consider our proposals.

Your feedback has been valuable in guiding our plans and we'd like to thank everyone who engaged with us at our consultations.

Over the coming months, as the examination progresses and the project continues to take shape, we'll keep you updated on our progress through regular community bulletins.

You may also begin to see an increasing number of our team out and about along the route of the pipeline. We will be carrying out a range of activities to support our plans, typically undertaking surveys to help inform the detailed design of the pipeline. We will always try to carry out this work with the least possible disruption to local people.

What happens next in the application process

The Planning Inspectorate is now responsible for the examination process. This involves a careful consideration of the documents we have submitted and will include a number of hearings close to the pipeline route.

At the end of the examination, the Planning Inspectorate will make a recommendation to the Secretary of State for Energy Security and Net Zero. Ultimately, the Secretary of State will make a decision on whether or not to grant development consent.


Upcoming work

In the coming months, you may see ongoing activity in the vicinity of the former Theddlethorpe Gas Terminal. We will be carrying out the required inspections on the existing offshore pipeline.

There will be some vehicles, along with temporary lighting on site due to the reduced daylight hours. The lighting will be low level, and positioned to minimise impacts.

You may see some workers on the site who will be carrying out night time monitoring related to the inspections.

We are also continuing our environmental survey work. This builds on the assessment work we have done to date, and will help inform the detailed design for the pipeline. We will provide more information on those surveys in future editions of the bulletin.
